COURSE OUTCOME FOR HISTORY HONOURS SYLLABUS FOR PART SYSTEM

Paper I: History of India from Earliest Times to C.650AD

This paper imparts knowledge regarding Geographical Background – Sources and approaches to ancient Indian history; pre and proto history of our country, background to early historic India, social and religious development during the period, emergence and growth of earlier dynasties like Maurya, Gupta and the empires in Post Maurya period as well as in Post Gupta period

Paper II: History of India, 650-1556 A.D

This paper focusses on historiography and recent debates of early medieval India, Sources, nature of regional politics and Arab invasions. The socio, political, economic, religious and cultural features of early medieval India are mainly discussed throughout the paper. The history of Delhi Sultanate is thoroughly described in this portion- Sultanate administration, socio-cultural –political situation and religious developments of Delhi under Sultanate. This paper ends with brief discussion on Afghan despotism.

Paper III: History of India, 1556-1857 A.D

This paper mainly deals with the history of Mughals in India-historiography, Sources, Overview of the growth of Mughal power till Akbar, Rural economy and society, urban developments. It also discusses cultural, literary and religious developments during this time, Rise of the Marathas and the decline of Mughal Empire. Further it also deals with The emergence of the English East India Company as a political power, Economy and society under Company rule and Indian responses to the West.

Paper IV: Transformation of Europe from 15th to 17th Centuries

From this paper students learn about the history of transformation of Europe during the period from 15th century to 17th century with focusses on Fall of Constantinople, Crisis of Feudalism, Economic Crisis and Commercial Decline in Europe in the 14th century, development of Science, technology and the age of discovery, Economic expansion of Europe in the 16th century, Renaissance and Humanism, formation of the early modern state, Reformation. It also discuses The economic expansion of Europe in the 17th century, Peace of Westphalia and the emergence of modern European state system and The Crisis of Absolutism.

Paper V: History of India, 1857-1971 A.D

This paper helps students in understanding the consolidation and expansion of British rule in India. It discusses right from the Revolt of 1857,economy during early days of company rule, Ideologies of the British Raj, Differential impact of colonialism, Growth of modern education, Growth of early political associations, Socio-religious revivalist/reform movements and Women in modern India. Next it focusses on Historiography of Indian nationalism and the foundation and growth of INC. Topics which follows are emergence of Gandhi and relevant political development, Revolutionaries and left movements, provincial ministries, various plans of Britishers in India, knowledge about communal politics, partition

in India, Framing of the Indian constitution and establishment of parliamentary democracy., Making of Indian foreign policy and ends with topics on Fragmentation of Indian Politics – rise of regional parties and India's role in the Bangladesh Crisis.

Paper VI: History of Europe from 1789 to 1919 AD

This paper is focused on the history of Modern Europe from 1789 to 1919 AD. It discusses The 18th century Europe, French Revolution, emergence of Napoleon Bonaparte in Europe and his expansion, consolidation, downfall. Vienna Congress, Metternich, Bismarck and his diplomacy, emergence of the national states in Central Europe, Industrialisation of Europe, European imperialism and impact of the War on old order – the collapse of the dynastic empire – Russian Revolution.

Paper VII: World since 1919

This paper concisely gives an overview of World politics since 1919, it discusses Peace settlements of 1919, developments in Europe during the inter-war period, The world after 1945, Decolonisation and emergence of the Third World, Regional theatres of the cold war, Communist Revolution and Emergence of China in world politics, transition from Bipolarism to Uni-polarism, Rise of terrorism and India's relation with her neighbours.

Paper VIII (A): History of East Asia since 1839

This paper is divided in two units. In the first unit students learn about Chinese traditional society, Colonial penetration and Chinese response, emergence of Nationalism and Communism in China. Canton commercial system, opium war, open door policy, Taiping Rebellion, Boxer Rebellion, Restoration, Reform, Revolution, Economic development and industrialization.

In the second unit students learn about Japan- Pre-Restoration period, Meiji Restoration, Meiji constitution, Abolition of feudalism and economic growth, Sino-Japanese war, Anglo-Japanese war, Russo-Japanese war, Manchurian crisis etc.

COURSE OUTCOME FOR HISTORY GENERAL SYLLABUS FOR PART SYSTEM

Paper-I: Indian History (Pre-historic times to Sixteenth Century A.D.)

This paper discusses the history of India from the pre-historic era till 16th century. It covers topics like sources and its interpretation of ancient and medieval India, changing political scenario from later Vedic times to the Sultanate ,economy, society and religion and also development in the field of literature, art and architecture.

Paper II: Indian History (C. 1526 to 1914 A.D.)

This paper broadly discusses the period from the disintegration of the sultanate to the coming of the English East India Company. It focusses on decline of Sultanate, emergence of Mughals, Political expansion and consolidation, Akbar's reign, Development in the Post Akbar period, Aurangzeb, Rise of Shivaji and finally decline of the mighty Mughals. Thereafter it discuses Early stages of the rise of the E.I. Company, Colonial economy, instances of early resistance to company rule and the slow evolution of Reformism and Westernisation.

Paper III: Modern Europe (1789-1939)

This paper focusses on Foundation of Modern Europe-Renaissance and Reformation, French revolution, Rise of Napoleon, Political Developments in Europe from 1815-1870. It also briefly covers the topics like Society and Economy in Nineteenth Century Europe, Modern Imperialism 1871-1914, First World War-its origin, Russian Revolution and Peace Settlement of 1919. It ends with the condition of Europe between 1919-1939-Consolidation of economic and political power of the Soviet State, Rise of Fascism in Italy, Nazism and Germany, Outbreak of the Second World War ---Different Interpretations.

Paper IV India and the world 1914-1964: Selected Themes

This paper discusses parts of Indian National Movement and also parts of World History. It starts with Impact of the first World War on India economy, society and polity; Emergence of Gandhi in Indian nationalist politics, Gandhian Mass Movements followed by coming of Subhas Chandra Bose and role of INA, Demand for Pakistan and its repercussions, Post war upsurge and different strands of protest politics; partition and the Transfer of power, Adoption of a republication constitution in 1950, Nehru era and ends with discussion on topics of world politics like bipolarism and its impact, Rise of third World and Impact of the Cold War

COURSE OUTCOME FOR DEPARTMENT OF HISTORY

The envisaged outcome of the CBCS syllabus of History designed for undergraduate level pupils interested to take up history as their graduation subject is to provide the students with an idea of how and when the Homo Sapiens emerged as one specie and how this specie evolved in stages to produce the History of the Human civilization as we know it today. It focusses on history of India from the period of pre-history to modern times and history of other countries apart from India like Europe, China ,Japan, etc. enabling students to study in comparison for a better understanding and in depth knowledge.
